I propose that the new park on Pattullo Avenue be named Herbert Milnes Park or perhaps Herbert Milnes Natural Park (since I presume it is a natural park).

Herbert Milne arrived in Woodstock from his home in England in1928. Herbert, an avid naturalist, helped form the Woodstock Naturalist Society (now the Woodstock Field Naturalists) in 1934 and was elected its first president. Throughout his lifetime he passionately wrote observational field notes on the flora and fauna in and about Oxford County. He also captured their images in beautiful, lifelike watercolours which often exhibited at the Museum and elsewhere.

A long time scouting enthusiast he organized several scout troops and in 1970 was awarded the Silver Acorn Award, the highest award for scouting in the province.

Through scouting he gave great encouragement to local boys to learn about nature.

When his health prevented him from having an active outdoor life her became curator of the Oxford Museum where he published several local history books.

Herbert Milnes died in 1980.

He made a great contribution to Woodstock, it is time this contribution is recognized, What better way than in the name of a natural park?

#### AIM:

To obtain City Council approval to enter into an agreement for funding from the Province of Ontario.

#### **BACKGROUND**

On June 29, 2020, the Province of Ontario announced a new program. The Municipal Transit Enhanced Cleaning (MTEC) funding is being provided to reduce the risk of exposure to COVID-19 on public transit systems.

The Ontario Government is providing up to \$15 million to 110 municipalities across the province to support enhanced cleaning of municipal public transit systems to keep passengers and employees safe and help reduce the transmission of COVID-19. To allocate the \$15 million across 110 municipalities, the funding will be distributed amongst municipalities using a modified version of our gas tax funding formula. The modification includes a \$500 base funding amount for each recipient in addition to the funding distribution determined by 70% ridership and 30% population; utilizing the same data that was used to determine the 2019-2020 Gas Tax program allocations.

MTEC funding will be flowed through an executed Transfer Payment Agreement (TPA) between the province and the municipality. Payments are to be based on a one-time claim for eligible expenditures.

The municipality has been allocated a maximum funding amount, with funding subject to the municipality meeting the terms and conditions of the executed TPA, including the eligibility requirements set out in the TPA.

#### COMMENT

Eligible costs will include direct costs incurred by the municipality on or after April 1, 2020 and on or before December 31, 2020. Eligible costs will include items considered to have been properly and reasonably incurred and are necessary for the enhanced cleaning of transit vehicles and any other public and non-public facing transit assets that provide or support transit services. In addition to having been incurred, these costs will have to have been paid by the municipality prior to being submitted to the province for payment and may include:

- Costs of cleaning materials for the MTEC;
- Costs of hand sanitizer for passenger and staff use;
- Costs of safety wear for the MTEC, such as gloves or goggles;
- Costs of equipment purchased for the MTEC;

- Costs of contracted services for the MTEC;
- Costs of salaries, including redeployment of staff, for the MTEC;
- Any other cost that, in the opinion and at the sole discretion of the province, is necessary for the MTEC.

Regardless of the municipality's total eligible cost related to enhanced transit cleaning, the province does not intend to provide funding above the dedicated allocated amount outlined to each municipality.

In order to receive the funding, the City of Woodstock needs to:

- 1. Confirm interest in seeking MTEC funding;
- 2. Execution of a Transfer Payment Agreement;
- 3. Passing of an authorizing bylaw;
- 4. Provide a report on expenditures prior to January 29, 2021.

The estimated costs that the City has been approved for is \$21,106.00. To date the City has incurred costs in excess of \$28,000 for labour and materials to protect against COVID-19 (items such as gloves and masks and other cleaning supplies for extra cleaning on the buses, additional staff time to complete the cleaning and installation of bio-shields on the buses).

Re: Street Renaming – Prince Andrew Crescent

**AIM** 

To rename the street Prince Andrew Crescent.

#### **BACKGROUND**

At its meeting on March 22, 2018, Council approved several street names in the Havelock Corners, Phase 4, residential subdivision located south of Oxford Road 17, east of Arthur Parker Avenue, and west of Oxford Road 4 (see attached Figure). One of the streets named was Prince Andrew Crescent. Prince Andrew Crescent was recently constructed by the developer with homes currently being built.

It has come to Staff's attention that due to recent news events this street name may not be appropriate. Also, the name is similar to another street in the west end of the city, St. Andrews Road, which may cause confusion with deliveries, emergency services, etc. As a result, Staff is seeking Council approval to rename Prince Andrew Crescent.

#### **COMMENTS**

Thames Developments and Kingsmen Group, the developer and builder at Havelock Corners, respectively, have confirmed to Staff that they are supportive of the proposed renaming of Prince Andrew Crescent, despite some inconvenience it may cause them. They have also indicated that none of the homes on Prince Andrew Crescent are currently occupied and first closings are scheduled for March, 2021. Therefore, it may be prudent to rename the street as soon as possible before homes are transferred into individual ownership.

Policy GA001 provides a framework for the changing of street names within the city and is attached herein. It includes requirements to advertise the proposed name change in the local newspaper, posting on the city website, and holding a public meeting prior to Council proceeding with the passage of a by-law. As there are no homes currently occupied and the developer and builder are supportive of the proposed street renaming, Council may consider foregoing Policy GA001 and decide to rename the street at today's meeting in order to expedite the process.

If Council chooses to rename the street at today's meeting, Council is asked to consider the name Silverwood Crescent. Silverwood is a name suggested by the developer and is on Council's list of approved street names (see attached).

# Options available to Council include:

- Renaming the street following the developer's suggestion.
- Choosing another name from Council's list of approved street names.
- Directing Staff to proceed with the street renaming following Policy GA001.
- Some other option.

If Council decides to rename the street at today's meeting, a by-law will be presented to Council at the next meeting and if passed and registered will make the new street name official. If Council decides to follow Policy GA001, it is expected that a second report to Council will be prepared that will summarize the results of any public input received and recommend a new street name for Prince Andrew Crescent. This report would also request Council to pass a by-law at a subsequent meeting to make the new street name official.

If Council chooses to rename the street and a subsequent by-law is passed renaming the street, Staff will notify agencies such as Canada Post, MPAC, Bell, Rogers, Enbridge, ERTH, Hydro One, Oxford County, etc. regarding the name change.



# **Statement Of Principle**

To provide a framework for the changing of street names within the City of Woodstock.

# **Administration**

A change of street name may be considered by Council if:


A request for a change of street name in the form of a petition signed by at least 75% of the residents on the street requesting the change; or

A resolution of Council is passed requesting a change of street name.

Where possible, historically significant names are to be used; a listing of which is provided by the Clerk when the request is considered by City Council.

Prior to Council proceeding with the passage of a by-law, the change in name requires advertising the proposed change in a local newspaper, posting on the website and holding a public meeting.

#### **BY-LAW NUMBER 9411-20**

A by-law to provide for the changing the name of parts of highways in the City of Woodstock.

**WHEREAS** the Councils of local municipalities are authorized to pass by-laws pursuant to the provisions of Sections 27 and 31 (2) of Chapter 25 of the Municipal Act, S.O. 2001, and amendments thereto, to provide for the naming of highways.
